

“Not the Enemy”

I have not been in OA long, about two years. But because I am only 20, many of my experiences have been with OA alongside. I have noticed a recent emphasis from some members and groups on their food plans, in particular the exclusion of certain ingredients (flour, refined carbohydrates, or sugar). The theme of this sharing seems to be that one should become willing to let go of one more of these substances. This is not the only path.

While I am grateful to hear everyone’s story, I know my path doesn’t need to end with me letting go of anything (especially physical) to be a happy, grateful, non-compulsive OAer. Sugar and white flour, while possible poison for some, aren’t the enemies.

However, I recognize the absolute necessity of member autonomy in food and in other aspects of program. If particular substances are the enemy for some members- with great glee for anyone working their program and having it work- I am free and willing to acknowledge the right of members to do what works for them, as I have the right to do what works for me.

My experience tells me many different food-plan variations can work. A member’s program and food plan are his or her own matter. The last thing I wish to bring about is a rift that causes controversy (oh, how I do like those Traditions--they are so smart!). I advocate a balanced presentation of feelings on recovery experiences, something akin to the three-legged-stool approach where physical, emotional and spiritual parts (at least!) must be addressed to give a full picture.

Thank you for your stories and shares. With love, the best of all, in all.





PTI Meeting Minutes 5/20/16 - 6:30PM

Please note, discussions are loosely summarized; not quoted. Jessica substituted for JC, as Secretary, to take the Meeting Minutes. Ruby also took notes and tried to provide Jessica with a laptop since she only has an iPad, but couldn't remember password, so Julie lent Jessica paper to handwrite the notes. Please carefully compare Jessica's notes with Ruby's, as this was her first time, and there are a few confusing items, which need clarification.

Attendees: Jason J., Donna D., Cynthia, Jessica M., Shirley P., Dawn H, Chrissy M., Lee, Julie O., Jim L., Joan R., Tiffany R., Ruby H, Lynn E., Pat G.

Additions to Agenda:

Joan - Survey on Diversity, will read if there is time. Will discuss Inventory as well, if there is time.

Joan - Gave info on Photo Booth and, if time, we will take a vote.

Donna - Wanted to speak but was asked to bring it up when New Business was discussed.

Open with the Serenity Prayer

This is a spiritual program so let's remember to keep principles before personalities, please.

Introduction & Representation from what meeting. Joan passed a sheet around for completion, given to Jessica for Secretary, JC.

Anyone new to Intergroup today? No newcomers or visitors.

Reading of 5th Step by Ruby, 5th Tradition by Tiffany, and 5th Concept by Julie.

Approval of Secretaries April Minutes, - approved. Joan apologized for having to cope with her brother's-in-law death. Ruby motioned to approve, Tiffany seconded, all in favor, no opposed, motion passed.

Changes to Agenda:

Add that the Treasurer's Report was approved; not just "moved to approve".

Bylaws: Article 4 states that it is not a meeting. The Bylaws have been passed and typos corrected. World Service is a Delegate; not a Representative. With changes, Ruby motioned to approve, Jason seconded, all in favor, no opposed, motion passed.

Treasurer's Report: Was emailed and receipt was confirmed. Lynn and Donna received hard copies. Treasurer reported we have \$1382, which includes \$512 in 7th Tradition donations and \$870 additional income (comprised of \$800 income from the FL State Convention and \$70 from the Men's Workshop on Integrity). Cynthia motioned to approve, Tiffany seconded, all in favor, no opposed, motion passed.

Passed the 7th tradition.

Committees Break for 5 minutes.

COMMITTEE REPORTS:

Ways and Means – Donna reported there are \$20 sample bags to take back to meetings with 50 kinds of magnets, tool beads, buttons with the 3rd Step prayer, 7th Step prayer, and OA Promise. Blocks of wood, potholders, makeup and nail polish are also available for sale. Jessica bought a \$20 sample bag and borrowed the large magnet sample board from Donna to bring to all her meetings.

IGOR – Joan reported May 2016 Newsletter was sent out to all Intergroups in SOAR 8, All IGOR reps, and all PTI.

BYLAWS – Julie and Ruby updated, added and corrected we are now a 501c3, ARTICLE II PURPOSE, Section 1 purpose. They are reviewing the P&P's.

PIPO – Cynthia reported the \$795 allotted amount for this committee has already been spent or committed for the rest of the year. \$595 for registrations, \$175 for literature, supplies, duct tape, and an easel sign. April 16 PIPO Workshop at Pinellas Park Library. They had a craft table with God boxes and duct tape to make bracelets, as well as items to make bookmarkers. They also provided water and had display tables with literature. There were members who spoke and shared on their recovery, experience, strength and hope. Overall, there were 19 attendees and 2 newcomers. Also, there was a booth at the Y, which Cynthia and Michelle manned. It was very overwhelming because a member did not show. But it was a great success, reaching lots of youth. Jason has been placing ads on Craigslist since his first day in PTI. There are 26 ads altogether, which are updated every other day, with approximately 50 metatags, which are search words, like "diet", "obesity", "weight", etc. Jason uses the PI and PO suggested formats for placing the ads. Tiffany's main goal is to reach youth because she is raising children herself and she sees how they have been affected. She has a 2-year relationship with BOGI (?) and 4-5 years with Azalea Middle School. She wants to start an after school program meeting, but the Principals are changing and the old one was very supportive but she will need to reach the new one to be as supportive. Also, a teacher must be involved, but she will keep us posted.

TSW – Lee reported May Men's meeting hosted a workshop at Friendship United Church, Step 5 Principle of Integrity with three speakers sharing on spiritual, emotional, and physical recovery. June 11th Action Plan @ Marge Porter Building at Turning Point of Tampa, 1-3pm. July 15-17th, Soar 8 Convention, Possible picnic fellowship event, Sat., August 20th - Bringing the Big Book to Life at Friendship United Church on Druid Road, Clearwater, 1-4pm. The church will be open at noon to bring lunch, if desired. Flyers are available for this event. September 24th – Writing Workshop, 1-3pm St. Pete Public Library Johnson Branch 1059 18th Ave S, St. Pete 33705.

FL State Convention Report – Julie (Mary T. is the other Rep, not present) stated that they met on April 30th to discuss new guidelines. Also, Theme "Together we can be Joyous, Happy and Serene in 2017" was approved. Location will be at the Holiday Inn Westshore Blvd and Cypress in Tampa, Feb 24 – 26. The evaluation for huggers/greeters improved, notebooks were exchanged, PTI Intergroup in charge of Hotel and Program – We need 4 main speakers, see Julie or Mary T. Topics for speakers will be announced/approved at the FL State Convention Meeting, directly after the conclusion of the SOAR 8 Convention.

OLD BUSINESS:

1. Treasury position has been passed on from Jason Johns, who took over for Sam in Dec 2014 until now, May 20th, to Ruby Hayn. The application was completed by Ruby. Tiffany made a motion to approve, Donna seconded the motion, all were in favor, except Jessica, who chose not to vote, motion passed. Ruby Hayn is the new Treasurer until December of 2017. Jason thanked everyone for allowing him to be of Service. Everyone thanked Jason for a wonderful job in Service.
2. Bylaws – Ruby stated that they forgot to put in the Bylaws that once a person becomes Chair, they cannot be a Rep. Committee chairs have the vote once that happens. We are going to keep it at 2 Reps per meeting. ARTICLE III Section 3, All in favor of changing bylaws. ARTICLE IV Meetings, Section 6, Intervals between meetings. Ruby moved to change. Also inserted 501c3 Section I Purpose in compliance with IRS code of 1954. ARTICLE 8 Nominating Committee, who has the voice and their qualifications, defines what PTI is. We all voted to ARTICLE 3, Sections 1 and 2. Will send to Trustee, Linda H. first and look at P&P division. Will go to the website. P &P – How to, Bylaws – Rules.
3. Scholarships. #3 and #2 front and back of application. Page 1 will be in P&P. No response for volunteers to be on the committee. There are 4 members on the committee, which was established by Joan. The qualification is they must have 6 months of continuous abstinence. Do we want to know who they are and do we agree with the process? Ruby gave an outline and Joan gave the application directions, such as applicants should have at least six (6) months of active/continuous group attendance. They should attend at least 2 (2) Intergroup meetings. Once before the early registration deadline and one following the event. They are asked to please do service at the event. If the event is a SOAR 8 Recovery and Business Assembly, it is suggested that they attend a committee meeting in the Business Assembly (A PTI Region 8 Representative can help). It is required that the applicant submit a written summary report and present it at the next PTI meeting after the event, to include what service was provided. Applicant is also asked to email the report to the newsletter editor at newsletter@oapinellas.org. The scholarship is open to any OA member that would like to attend any OA related conventions and retreats. The application must reach the treasurer of PTI before the early registration date on the event flyer. The application can be emailed to treasurer@oapinellas.org, given in person to PTI Treasurer at meeting, or may be mailed to ____.

The treasurer will provide a copy of the application to the committee for consideration. Scholarships will be dispersed depending on the funds available. Some may be partially funded, with a cap of \$200. Shirley and Cynthia wanted to verify their email addresses because they were not receiving any information. Donna clarified that some individual meetings have scholarships as well, so if applicants wanted to, they could double dip. Joan moved to approve the scholarship application guidelines, Julie seconded the motion, Lee wanted discussion, Donna opposed, motion passed.

4. Paid \$100 rent for PTI Meeting room. Joan proposed to pay again in December, making 2 payments per year.
5. P O Box – Ruby made a motion to locate the PO Box in close proximity to the Treasurer, Jason seconded the motion, no one opposed, motion passed. Right now the PO Box is at Countryside Village and is \$41 for 6 months.
6. Any other old business? Jim passed around the copies of “How to Make Motions” and asked if he could make a gentle reminder of crosstalk and other rules being broken, such as not addressing Madam Chair and not introducing ourselves with our name and “compulsive overeaters” before addressing the group. All agreed, but I don’t believe a motion was made, seconded or passed.

NEW BUSINESS:

1. Vice Chair Tiffany gifted cute magnets lovingly handmade from clothespins, thanking each member for their service to PTI. She also added pics to the WS flyer. (Not sure what flyer it is exactly, tried to call her, no answer. Asked Ruby and Joan, but they weren’t sure).
2. Julie applied for a scholarship last month. Cynthia made a motion to approve, Tiffany seconded the motion, all in favor, no opposed, motion passed. No mention of what the scholarship was for or the dollar amount requested.
3. Franciscan Center Team – we need volunteers, please take this message to your home groups. It will be held November 18-20, 2016 (or 2017?, as stated in the last meeting minutes.)
4. Unity with Diversity Survey from SOAR 8 – Joan asked if we had any types of special interest groups we would like to see for meetings. Jason suggested a lap band/gastric bypass group.
5. Inventory – 12 Step Within completed.
6. Jessica reminded Donna she had a New Business item to discuss, but she changed her mind.
7. Ended with the Serenity Prayer at 8:10pm.
8. No tabled items!


